DMPED: Re-Imagining Reeves Public Property Context

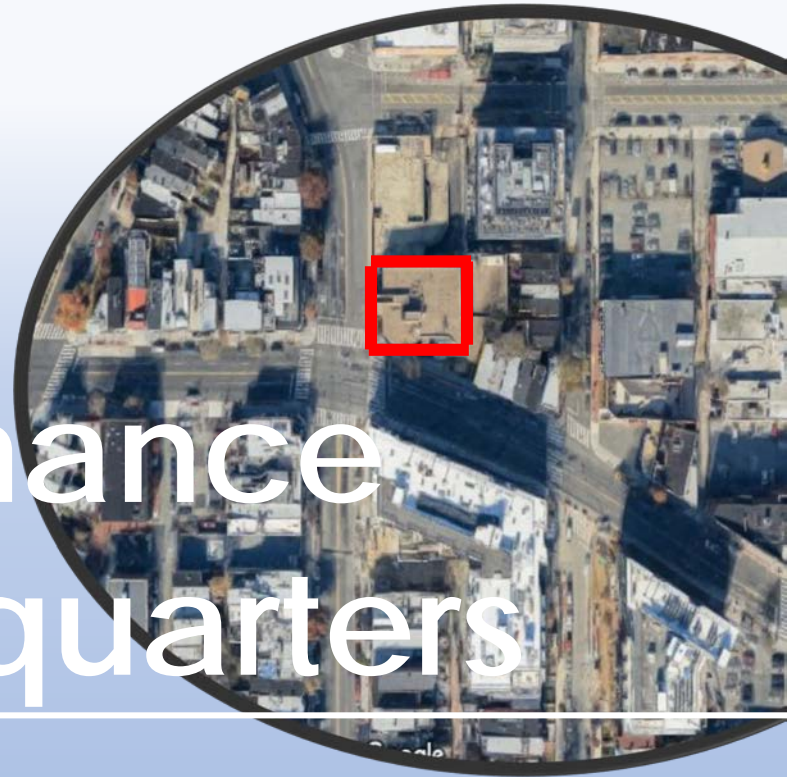

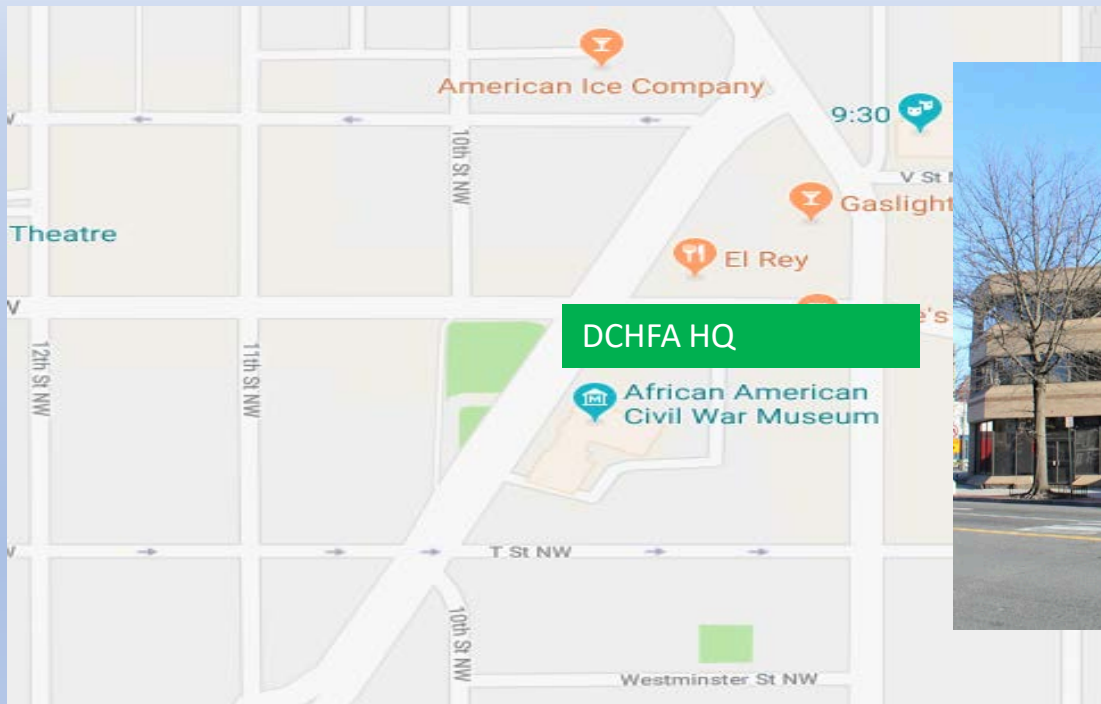

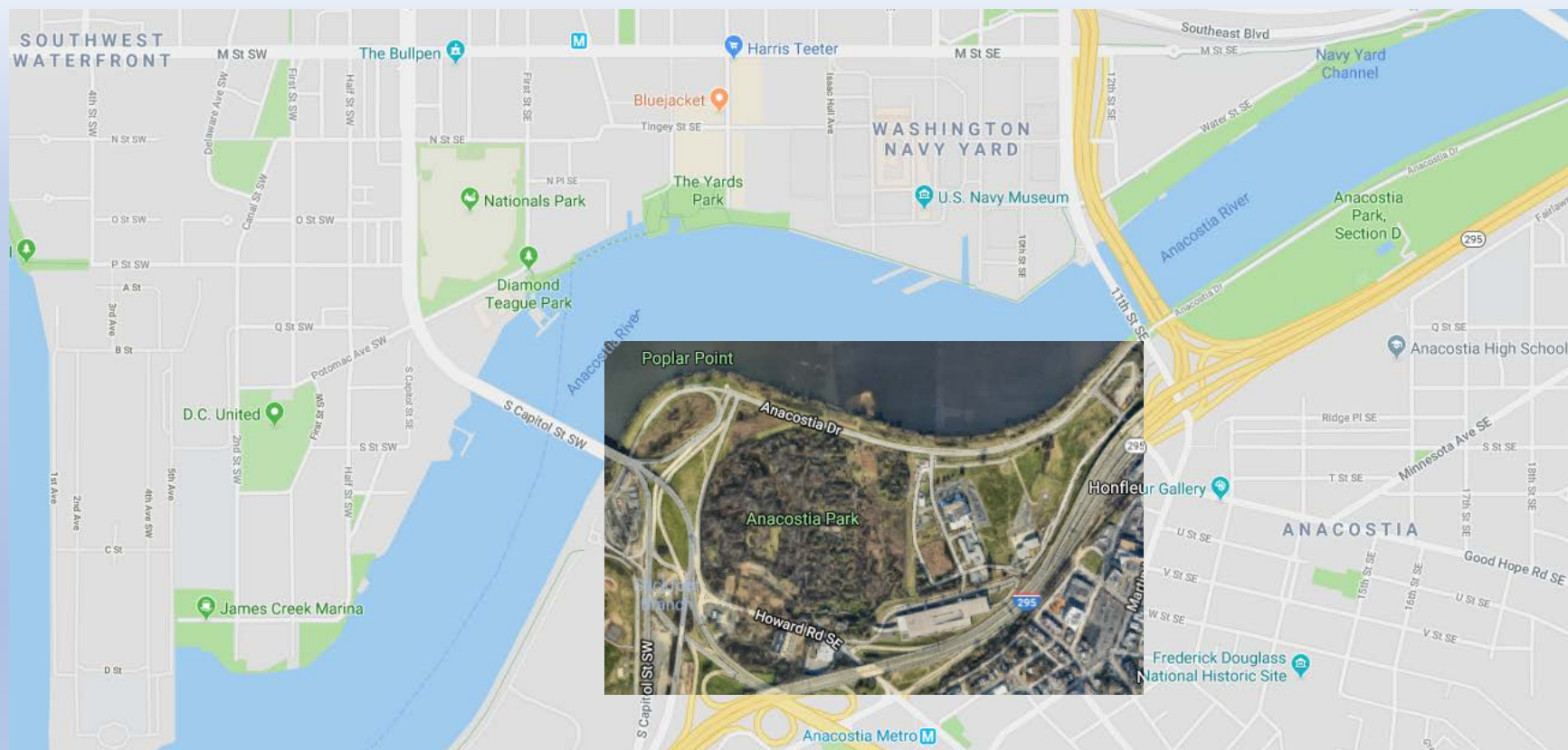
