 - A. Thomas Sanchez, Chair, ITIC

 - 1. Kevin Morgan, Workforce Sub-Committee
 - Held mtg on April 28, 2023.
 - Realized there is a gap in understanding needs of IT community.
 - Thomas Sanchez also noted that GW's Dean for the College of Professional Studies is offering certification programs and wants to create alignment across the District, with possible scholarships. Ximena Hartsock (BuildWithin) will be working on this effort as well.
 - On a related note, it would be good to get an update from the Greater Washington's Capital CoLAB Digital Technology Credential.
 - 2. Amber Wason, Entrepreneurship Sub-Committee
 - Held mtg on May 5, 2023.
 - Realized they're aware that a lot of resources exist, so resource mapping would be helpful. Some mapping efforts probably already exist, and should be gathered. Maybe a survey or data collection process through ITIC to see where things stand.
 - Talked a lot about the banking sector being reinvented.
 - 3. Cleve Mesidor, Education Sub-Committee
 - Held mtg on May 4, 2023.
 - Realized there is a need for a holistic opportunity for young people to be prepared for jobs of the future. Group is wondering how to offer that education. Would probably take legislation and partnership of local universities across the DMV. One of the goals is to have guest speakers participate and identify projects.
 - Identified a need for a government education representative on the ITIC.
 - Anika Holmes is part of the Workforce Investment Council (WIC) and is the DME cluster representative. Also serves on the Talent Tech Ready group.
