

# **Get Small Medium Business Growth Fund Ready**

## What is the Small Medium Business Growth Fund?

Mayor Bowser and the Office of the Deputy Mayor for Planning & Economic Development is investing \$5.4 million in the Small Medium Business Growth Fund, a program that will offer grants aimed to retain and expand district-based small businesses by supporting large scale capital improvements, large equipment purchasing, and technological advancements within retail, professional services, industrial-based businesses, and manufacturing industries.

The Small Medium Business Growth Fund targets:

- Professional Services (this includes technology/life sciences companies)
- Industrial-based
- Manufacturer
- Retail
- Small Business Investment Projects (for profit & non-profit\*)
- New businesses and existing businesses
- Startups participating in a DC accelerator/incubator\*

Grants made to small businesses will support funding under four categories. Businesses may apply for funding in one of the following categories:

#### Retail

Awards up to \$50,000 to support capital improvement, purchase of large equipment, and retail expansion.

#### Local Manufacturer

Awards up to \$100,000 to support capital improvement, purchase of large equipment on commercial property with a designated industrial use.

#### **Small Business Investment Projects**

Awards up to \$600,000 to support innovative projects that elevate the development of distressed and emerging neighborhoods throughout the district. Note: the project must be delivered within a 12-month timeline.

#### **Technology Advancement**

Awards up to \$200,000 to support technology advancements like automation, AI, Machine Learning, VR, robotic process automations, augmented reality, systems upgrades and processes that allow businesses to scale.

### **Am I Eligible?**

The Small Medium Business Growth Fund will be open to businesses that meet the following criteria:

- New for-profit businesses (including, but not limited to partnerships, limited liability companies, corporations)
- Existing for-profit businesses headquartered in DC (including, but not limited to partnerships, limited liability companies, corporations)
- □ Independently owned and operated businesses.
- □ Technology-based businesses, professional services, industrial-based, and manufacturers
- □ Retail businesses and service-oriented businesses

- Business participating in a DC accelerator/incubator program
- □ Maximum of \$15 million in annual revenue
- □ Local nonprofit (must be duly organized in the District of Columbia, must not be an affiliate of a national charter, must own building, and have ground-floor retail tenants)
- □ Less than 100 employees

### What Documents Do I Need to Apply?

Before you start your application, please prepare the following documents:

- 2021 tax returns, Annual Income Statement for past 3 years (2019, 2020, and 2021) or Annual Statement of Activities for the past 3 years (2019, 2020, 2021)
- Certificate of Clean Hands (dated within 90 days prior to application date). <u>Learn how to request</u> your certificate.
- DC Basic Business License (Request <u>here</u>)

### **Ineligible Business Applicants**

- □ Adult entertainment
- □ Auto body repair
- 🗆 Bank
- □ Liquor Store
- □ Home-based
- □ Bar or Nightclub, as defined by an ABRA license
- □ Construction/general contracting/architecture/design-build
- □ E-commerce business
- □ Seasonal (open only part of the year)
- □ Recipients of the Great Streets Grant, DC Locally Made Manufacturing Grant, Neighborhood Prosperity Fund during the award period October 1, 2021, to September 30, 2022.

#### How Do I Apply?

The application will open on Friday, April 22, 2022, at 4 PM (EST) and close on Friday, May 27, 2022, at 4 PM (EST). The application along with an Application Guide and FAQs will be posted on **The Small Medium Business Growth Fund Page (<u>DC Business Funding — #ObviouslyDC</u>)**

### **Commonly Asked Questions**

- When will I receive my award notification letter? We anticipate that notifications will begin in mid- June.
- What are the minimum and maximum amount of funds that I can receive? The funding category an applicant selects determines that maximum award amount.
- I have multiple businesses. Can I apply for more than one business to the Small Medium Business Growth Fund? You may apply for each business that has an EIN and separate business license. However, a maximum of two (2) applications may be submitted per owner.
- **My business is located outside the DMV. Can I apply?** You may **ONLY** apply if your business is opening a new location within the District of Columbia.
- What if I can't provide my documents in time? This is a competitive application. To be eligible for funding, businesses must provide all required documentation with their application, or application is deemed incomplete and no longer considered for a grant.
- The online GrantVantage application is not displaying a SUBMIT button, how do I submit my application? If you do not see a submit button, your application is incomplete and will not be reviewed. You must review your application and respond to all questions and checkboxes. Please review the application carefully.
- **Can I submit the application via email?** No. All applications must be submitted on the designated online portal no later than Friday, May 27, 2022, at 4:00 PM/ET. DMPED and its program partners are not responsible for unreadable, incomplete, and/or out-of-order submissions.
- Can I submit the same Certificate of Clean Hands that I used for other funding opportunities? No. A current Certificate (dated within 90 days prior to application date) must be submitted with application.
