In Section F: Period of Performance and Deliverables, we noticed that Task 5 lists up to 4 events (p23). Question: Can you clarify if the number of events in Task 5 is up to 4 overall or up to 4 over a specific number of months?</p> <p>R2 – The number of events in Task 5 is up to 4 overall. The events may occur at anytime during the contract and are not spaced out monthly or over a set period of timeframe.</p> <p>Q3 – Attachment J.3/J.4: Our consultant team does not plan to hire new staff for this project, if we were to be awarded the project, what are the expectations of completion of attachments J.3 & J.4?</p> <p>R3 – Attachments J3 – EEO Employer Information Report and Mayor’s Order 85-85 and J4 – DOES First Source Employment Agreement are required solicitation documents and shall be completed and submitted with offerors’ proposal.
