






SECOND FLOOR PLAN, SCHOOLHOUSE - 10<sup>th</sup> DIV.








CROSS SECTION. SCHOOLHOUSE - 10<sup>th</sup> DIV.


SECTION SHOWING PLUMBING PIPES


BASEMENT PLAN, SHOWING STEAM HEATING SYSTEM.

ON LOTS 2 TO 10, SQ. 615







PIPING SUPPORT DETAILS




PLAN OF EXISTING COURT SHOWING EXTENT  
OF CRACKS TO BE REPAIRED









TYPICAL LOUVER DETAIL IN EXISTING EXTERIOR WALL - SCALE - 1/2" = 1'-0"




DETAIL OF LOUVER IN UPPER PART OF EXISTING EXTERIOR OPENING - SCALE - 1/2" = 1'-0"













EXISTING AND DEMOLITION PLAN





PLAN OF EXISTING AND NEW BASKETBALL COURTS




PLAN OF EXISTING COURT SHOWING EXTENT OF CRACKS TO BE REPAIRED
